

Victoria Esplanade and Kangaroo Bluff Landscape Plan Review Consultation Report

The community consultation was undertaken from 30 July – 30 August 2019 via direct mail to 400 residents, on site signage directing users to the website and on council's Your Say Clarence website.

The consultation tools utilised on Your Say Clarence included:

- A survey: consisting of eight questions
- Ideas: providing an opportunity to offer ideas about the esplanade
- Stories: providing an opportunity to offer stories about time spent along the esplanade
- Places: providing an opportunity to offer suggestions about places within the esplanade

Your Say Clarence Community Feedback Summary:

- 39 responses were received for the online survey
- 7 ideas were received
- 5 place pins were posted
- 2 stories were received

In addition, council officers received several direct emails.

Key feedback themes from the survey results

Most valued elements of the area

• Views, the natural vegetation, pathways and the landscape, open space and the connection to the water.

Less favourable elements of the area

• Sharing the pathway, the condition of the landscape and car parking.

Suggested improvements

 Road issues, landscape conditions, additional park furniture, the shared pathway, existing vegetation by planting more Australian native trees and shrubs and establishing a canopy for shade over seating.

Is there adequate car parking?

- 29 said yes
- 10 said no



People who would like to see the edge between the road and vegetation improved to incorporate water sensitive urban design principles

- 33 said yes
- 6 said no
